CONSIGNMENT CONTRACT

What's New Again (WNA) specializes in and welcomes *current* designer clothing, handbags, jewelry, shoes, accessories and small home décor items.

1. Merchandise must be either NEW or "LIKE NEW" and currently in style (within two (2) years). NO vintage or outdated items will be accepted. All items must be laundered or dry-cleaned and SMOKE-FREE. We do not accept items that need repair. **IMPORTANT NOTE: ANY ITEM THAT HAS A NOTICABLE ODOR (ie: cigarette smoke, pet odor, moth balls, perfume, etc) WILL BE REJECTED IMMEDIATELY. THIS RULE WILL BE STRICTLY ENFORCED.**
2. All consignments must be accompanied by a completed and signed Inventory Checklist. Our preference is that items be delivered on hangers or neatly folded in shopping bags or bins. Consignor agrees to leave items at store location to allow Management ample time to evaluate. A minimum of forty-eight (48) hours is required for the evaluation process. Management reserves the right to decline any merchandise FOR ANY REASON.
3. Consignor will be notified by (please circle one) Email Phone upon completion of the evaluation. We will make two (2) attempts to notify you for pick-up of unacceptable items. If items are not picked up within five (5) days of last contact attempt, these items will be donated to a local charity.
4. The consigned price of an item will be set by Management to reflect current market price and demand.
5. The Consignment Contract is valid for a period of ninety (90) days, which begins when the merchandise is put onto the sales floor. Items may remain on the sales floor beyond the contract period until Management removes the items or Consignor contacts **WNA** to arrange pickup of unsold items, whichever occurs first. Consignor agrees to allow a minimum of twenty-four (24) hours from the initial contact for unsold items to be made available for pickup. If items are not claimed within five (5) days after agreed upon transfer date, all unclaimed items will be disposed of or donated to a local charity. Consignment contract is for a period of ninety (90) days. If Consignor requests items before this period expires, a fee of \$5 per item or a flat fee of \$25 (whichever is higher) will be charged to the Consignor. Fee must be paid prior to release of unsold items. Management reserves the right to cancel this contract at any time.
6. **WNA** reserves the right to markdown the merchandise at any time for promotional purposes. Markdowns depend on the condition, season and demand for the item and are solely determined by Management.
7. Commission payments to Consignors are 40% of the final Sales Price of each item. Consignors are paid by either check or store credit. Checks will be issued by request only with a minimum of five (5) business days notice.
8. **WNA** is open to the public Tuesday - Friday from 10am to 6pm, Thursday from 10am to 7pm, Saturday from 10am to 5pm and Sunday from 12pm to 5pm. We are not liable or responsible for any type of casualty or loss due to theft, customer damage, fire or any other cause or circumstance beyond our control.
9. Consignor must present proof of purchase/authenticity for all high end labels such as Louis Vuitton, Gucci, Prada, Chanel, Fendi, etc.
10. All sales are FINAL. We DO NOT refund, accept returns, or exchanges. This policy is strictly enforced.
