CONSIGNMENT CONTRACT

What's New Again specializes in and welcomes *current* designer clothing (dresses, separates, suits, evening wear), handbags, accessories, hats, coats, selected jewelry and shoes.

1. Merchandise should be either NEW or "LIKE NEW" and currently in style (within 2 years). All items must be laundered or dry-cleaned, SMOKE-FREE and preferably on hangers. We do not accept items that need repair.
2. All consignments must be accompanied by a completed Inventory Checklist. Consignor agrees to leave items at store location to allow Management ample time to evaluate. A minimum of 48 hours is required for the evaluation process. Consignor will be notified by (please circle one) **Email** **Phone** upon completion of the evaluation. Management reserves the right to decline any merchandise for any reason.
3. The consigned price of an item will be set by Management to reflect current market price and demand.
4. The Consignment Contract is for 90 days and this period begins when the merchandise is put onto the sales floor. **What's New Again** reserves the right to markdown the merchandise at any time for promotional purposes. Markdowns depend on the condition, season and demand for the item and are solely determined by Management. After 90 days, Consignor must contact **What's New Again** to arrange pickup of unsold items. Consignor agrees to allow a minimum of 24 hours from initial contact for unsold items to be made available for pickup. If items are not claimed within 5 days after agreed upon transfer date, all unclaimed items will be disposed of at Management's discretion.
5. Commission payments to Consignors are 40% of the actual Sales Price of each item. Consignors are paid by either check or store credit. Checks will be issued by appointment only with a minimum of 5 business days notice.
6. Consignment contract is for a period of 90 days. If Consignor requests items before this period expires, a fee of \$5 per item or a flat fee of \$25 (whichever is higher) will be charged to the Consignor. Fee must be paid prior to release of unsold items. Management reserves the right to cancel this contract at any time.
7. **What's New Again** is open to the public Tuesday - Friday from 10am to 6pm, Thursday from 10am to 8pm, Saturday from 10am to 5pm and Sunday from 12pm to 5pm. We are not liable or responsible for any type of casualty or loss due to theft, customer damage, fire or any other cause or circumstance beyond our control.
8. Consignor must present proof of purchase/authenticity for all high end labels such as Louis Vuitton, Gucci, Prada, Dooney & Bourke, Chanel, Coach, etc.
9. All sales are FINAL. We DO NOT refund, accept returns, or exchanges. This policy is strictly enforced.
10. By signing below, Consignor certifies that they solely own all items being consigned and such merchandise is free and clear of any liens or encumbrances.
